Current definition of Anti-Semitism:

"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

Steps You Can Take To Stop Anti-Semitism:

- 1) Raising awareness on the matter by talking about it. Speaking to youth, in schools when appreciate, will help. We see a lot of anti-sematic social media posts. We need to be able to stand up and denounce these actions.
- 2) When there are these awful attacks on the Jewish community they often feel alone. Show solidary and reach out to local faith to share that you support them.
- 3) Signing onto the International Holocaust Remembrance Alliance and resolution against anti-Semitism

SR, Shared that there are no longer specific awards or number of awardees on Honor Roll. We can independently decide how many are recognized.

EB, So we will vet submission, do we have a criteria? Maybe we can pick a certain amount for segment or section.

HRC Member Ted Mancini to share an update on Crime Petition:

TM, Crime bill never made it out of committee. Working to hear back from town leaders to see if there will be movement on the topic.

SR, Reminded that bill language would be shared, asked if it was available.

TM, The bill died in committee so no language to share.
