 - Discuss Meeting with Police Chief Riddick: Adrienne Billings-Smith commented (good meeting)
 - Sarah R. mentioned: Promoting Alternatives to Police in Schools: Addressing the School to Prison Pipeline Panel (10/6/20) and the legislation needs to be brought up to Tom Moore in WHPS meeting.
 - Sarah R.= informed the Commission of the Town's (Town Manager Matt Hart email) decision to cancel the 10/7/20 Public Safety Committee meeting which was discuss the Civilian Review Board
