The WHCEC is in the process of assembling the list of issues that it can support and recommend: consensus seemed to be that priority items were: Energy Plan, SMART, and food waste collection. Catherine will pass this information on to the Sust CT Committee to be amalgamated with other input from staff and other town commissions.
