- 1. <u>1500-1502 New Britain Avenue</u> Application filed on behalf of West Farms Mall, LLC, owner of property located at 1500-1502 New Britain Avenue known as Westfarms Mall within Special Development District (SDD) #12. The application seeks permission to undertake exterior façade renovations to the tenant space just north of the easterly-facing "mall" entrance for a Maggie McFly's restaurant, including associated signage, landscaping and parking modifications.
