

TOWN OF WEST HARTFORD. The Town of West Hartford will submit to the U.S. Dept. of Housing and Urban Development (HUD) its 2020 Consolidated Annual Performance Evaluation Report (CAPER) as required of the Town of West Hartford to utilize Community Development Block Grant (CDBG) Funds.

In alignment with the Town of West Hartford's CDBG Citizen Participation Plan, the CAPER is available to the community for a review period of 15 days before submission to HUD. This year, the **2020 CAPER** will be available for review and comment by West Hartford citizens from **Tuesday October 26, 2021, to Monday 15, 2021**. On or before November 18, 2021, The Town of West Hartford will submit the 2020 CAPER to HUD.

- The body of the email must begin with the interested person(s) full name and street address.
- Comments must be germane to the CAPER report.
